



"Star is large, small, wide or long. "Stripe" is long, wide or narrow. "Snip" (on nose) same designations. "Blaze" is entire face white. Describe white on legs from hoof upward as coronets, half-pasterns, pasterns, fetlocks, socks, stockings, etc.





ELIGIBILITY & RULES

Horses are eligible for registration as <u>Half-blooded</u> which have one fully-registered parent -- for example, American Saddlebred, Hackney, Morgan, Quarter Horse, Standard Bred, Walking Horse, or Welsh, said parent being duly registered with the respective registry association of the various breeds -- and the other parent of such type, breeding and quality as in a satisfactory riding horse.

<u>A 3/4 blood</u>, such as a 3/4 Morgan, is one whose 1 parent is a fully-registered horse and the other parent is a registered half-blood of the same breed. Likewise a 7/8 blood would have for parents a full-blooded and a registered 3/4 blood of the same breed.

A **Crossbred** has two registered parents of different breeds, such as an Appaloosa-Welsh.

Select name choices carefully. The Registry reserves the right to reject a name for any reason deemed unsuitable.
